PENCOM TO
FINE PFAS OVER
PENSIONERS'
DELAYED

The National Pension Commission (PenCom) has promised to sanction Pension Fund Administrators (PFAs) over the spate of delays in the payment of pension benefits, among other related infractions. The Commission stated this in its 'Revised regulation on the administration of retirement and terminal benefits.'

As stated in the revised regulation, "A PFA that fails, neglects or refuses to enlighten the retiree on the features of Programmed Withdrawal and Retiree Life Annuity to enable the retiree to make an informed decision shall be liable for an administrative sanction of N500,000."

According to PenCom, a situation where a PFA delays the submission of a request for approval to the Commission, for the payment of benefits to a retiree/beneficiary for more than 10 working days from the date of submission of relevant documents, shall attract a penalty. Specifically, the PFA will pay an administrative fine of N200,000, and N20,000 for every further day of delay thereafter.

Similarly, where a PFA delays the payment of retirement benefits for up to five working days after receipt of no-objection from the Commission, PenCom said the affected operator would pay an administrative fine of N200,000 and N20,000 for every additional day of delay thereafter.

The regulator stated that "A PFA and/or Pension Fund Custodian that pays retirement benefits without the Commission's prior no-objection shall pay an administrative sanction of N1m. "This is in addition to refunding either the principal amount so paid or lost investment income thereof, whichever is higher."

According to PenCom, a PFA that pays an amount in excess of what is specified on the no-objection approval granted by the Commission will be liable to refund of the overpaid amount and the investment income lost arising from the transaction, except where the difference is a residual amount or is as a result of the return on investment.

It further stated that any PFA that pays an amount lower than that specified on the no-objection approval granted by the Commission, would, in addition to paying the differential to the retiree, pay an administrative sanction of N500,000.


"Any PFA that negligently submits to the Commission, a request with incorrect information that is likely to result in an accelerated depletion of the RSA balance of a retiree, will pay an administrative sanction of N500,000," noting that the PFA would refund to the RSA both the amount that was overpaid and the lost investment income.

PenCom said any PFA that negligently submits to the Commission, a request with incorrect information and later request the permission of the Commission to resubmit the request, would pay an administrative sanction of N1m per RSA.

The regulator said, "Any violation of any provision of this regulation for which no sanction has been prescribed shall attract an administrative sanction of not more than N2m.

"All sanctions in this regulation shall be charged to the operator's profit and loss account and the burden shall not be transferred to the employees of the operators."


INVESTMENT NEWS FUND PERFORMANCE REPORT



The headline inflation rate rose by 22bps to 15.92% yoy in March 2022, from 15.70% recorded in February 2022. This arose from price increments in gas and liquid fuel among others. Meanwhile, the food price index grew by 9bps to 17.20% when compared to the previous month's rate, while Core inflation stood at 13.91% MoM. We foresee elevated inflation levels in the near term, as oil prices continue to rise as a fallout of the on-going Russia-Ukraine crisis. In addition, hawkish stance adopted by global monetary authorities could push inflation higher, Nonetheless, these expectations are barring any radical global/macroeconomic shifts and apex bank interventions.

The Federal Ministry of Youth and Sports Development has charged the Nigeria Football Federation (NFF) to set up machinery for the Federation's general elections, which are expected to hold in September this year. The ministry has also directed the NFF to set up a three-man technical crew for the home-based Eagles and invite 30 players to the team to start preparations for upcoming competitions.

Rising from a meeting with the NFF and representatives of the Presidency following the country's failure to qualify for the Qatar 2022 World Cup, Sports Minister, Sunday Dare, expressed his determination to overhaul the country's football ecosystem.

According to a source, who pleaded anonymity, the meeting took an interim report and review of the failure to qualify for the World Cup, after which it deliberated on steps that would urgently reposition Nigerian football and rescue it from its current state from the grassroots, the leagues to the national teams.

One of such steps is the immediate restructuring of the local league, with the ministry insisting that the Super Eagles' inability to qualify for the World Cup was a manifestation of the failure of the league to produce players for the national team, the source disclosed, adding that the minister requested for an immediate status report on the league after which he would take further actions.

The source, who was part of the meeting, added: "The meeting agreed to search, set up and announce a three-man technical team of Nigerian coaches to handle the home-based team.

HEALTHY LIVING

Regular handwashing is one of the best ways to remove germs, avoid getting sick, and prevent the spread of germs to others. Whether you are at home, at work, traveling, or out in the community, find out how handwashing with soap and water can protect you and your family.

Washing hands prevents illnesses and the spread of infections to others

Handwashing with soap removes germs from hands. This helps prevent infections because:

- People frequently touch their eyes, nose, and mouth without even realizing it. Germs can get into the body through the eyes, nose and mouth and make us sick.
- Germs from unwashed hands can get into foods and drinks while people prepare or consume them. Germs can multiply in some types of foods or drinks, under certain conditions, and make people sick.
- Germs from unwashed hands can be transferred to other objects, like thandrails, table tops, or toys, and then transferred to another person's hands.
- Removing germs through handwashing therefore helps prevent diarrhea and respiratory infections and may even help prevent skin and eye infections.

Not washing hands harms children around the world

About 1.8 million children under the age of 5 die each year from diarrheal diseases and pneumonia, the top two killers of young children around the

world.

- Handwashing with soap could protect about 1 out of every 3 young children who get sick with diarrhea 2, 3 and almost 1 out of 5 young children with respiratory infections like pneumonia 3, 5.
- Although people around the world clean their hands with water, very few use soap to wash their hands. Washing hands with soap removes germs much more effectively 9.
- Handwashing education and access to soap in schools can help improve attendance 10, 11, 12.
- Good handwashing early in life may help improve child development in some settings 13.
- Estimated global rates of handwashing after using the toilet are only 19% 6.

Handwashing helps battle the rise in antibiotic resistance

Preventing sickness reduces the amount of antibiotics people use and the likelihood that antibiotic resistance will develop. Handwashing can prevent about 30% of diarrhea-related sicknesses and about 20% of respiratory infections (e.g., colds) 2, 5. Antibiotics often are prescribed unnecessarily for these health issues 14. Reducing the number of these infections by washing hands frequently helps prevent the overuse of antibiotics—the single most important factor leading to antibiotic resistance around the world. Handwashing can also prevent people from getting sick with germs that are already resistant to antibiotics and that can be difficult to treat.




